- (3) Motion was made by Councilman Burnett to approve the grant request for 2016 Homeland Security Funding in the amount of \$80,000 for a backup generator for the South Lincoln Training and Event Center; seconded by Councilman Reetz and unanimously approved by Council present.
- (4) Motion was made by Councilman Burg to authorize the request from the Muley Fanatic Foundation for \$500 for rental fee for their banquet; seconded by Councilman Burnett and unanimously approved by Council present.
- (5) Motion was made by Councilman Burnett to approve the submission of the Fossil Basin Promotion Board Grant request in the amount of \$458.25 to print pamphlets; seconded by Councilman Reetz and unanimously approved by Council present.
