PURPOSE

The Lincoln County Leadership Institute builds a solid pathway to leadership by cultivating relationships, enhancing skills, and empowering individuals.

OBJECTIVES

- Encourage individuals to build and enhance relationships within their business and the community
- Balance personal and professional growth
- Develop dynamic leadership skills through education
- Inspire participants to take on leadership roles
- Increase understanding of Lincoln County issues, economics, and resources

DESCRIPTION

The Lincoln County Leadership Institute will provide both educational and participatory experiences. The program consists of eight full day sessions from October through May. The curriculum is a blend of theory, skills, and issues that include participation in community based experiences, board meetings, and public hearings.

Participants will explore tools associated with succeeding on the job, and in job-related issues. Strategies to adapt to leadership challenges will be explored.

Boards and organizations play a vital role in every community. Techniques to increase understanding of key components to effective meetings, parliamentary procedure, group dynamics, and skills for effective boards and organizations will be learned.

SELECTION

The Lincoln County Leadership Institute is open to emerging and established leaders who wish to increase their leadership skills, knowledge of Lincoln County, and participation in the community. Tuition is \$150 which includes instruction, materials, and meals. Participants must provide their own transportation. Attendance is required for the first session and is expected at all other sessions. Participants absent from more than one session will not graduate. Class size will be limited to 18 participants. Selection of participants will be based on criteria specified on the application form. Application deadline is October 2, 2017.

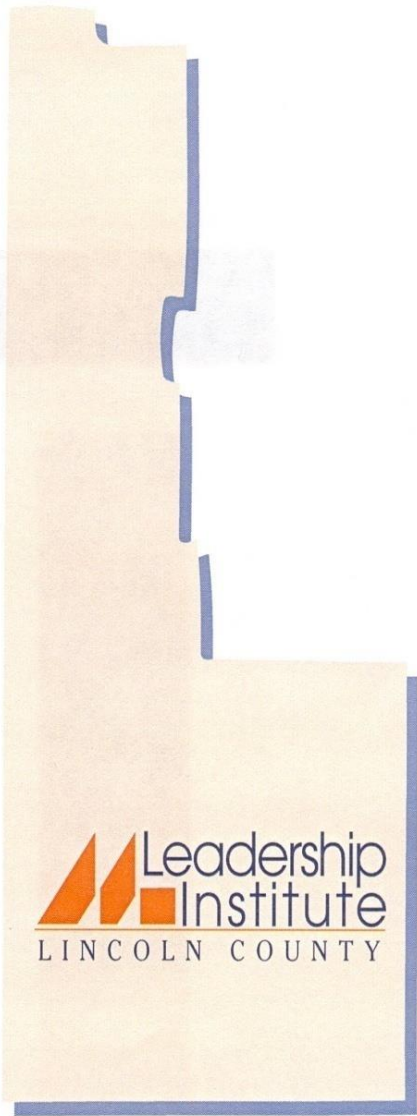
