- (d) Motion was made by Councilmember Hicks to Pass on 1st Reading Ordinance No. 2022-869, Amending Section 23-59, Water/Sewer Requirements, and Section 18-8; Required for Occupied Land Within Two Hundred Feed of Public Sewer; Exceptions; seconded by Councilmember Bowen and unanimously approved by council.

Dale Hicks verbally resigned as the City liaison to the Fossil Basin Promotion Board.

(e) Motion was made by Councilmember Bowen to give the Town of Diamondville a 60 day notice of the request to dissolute the Kemmerer-Diamondville Fossil Basin Promotion Board; seconded by Councilmember Hicks. The mayor then called for the question. Those voting "Yea" were Councilmember Bowen, Councilmember Price, and Councilmember Hicks Those voting "Nay" were Councilmember Quinn, Councilmember Rudy, and Councilmember Thornock. Mayor Thek broke the tie with a "Nay" vote. Motion failed.
