

The Kemmerer City Council met in regular session this 25th day of April, 2022, at 7 p.m. in the City Council Chambers, City Hall, Kemmerer, Wyoming. The Pledge of Allegiance was recited. Present on roll call were Mayor William Thek, Councilmember Robert Bowen, Councilmember Dale Hicks, Councilmember Eric Rudy, and Councilmember Jamie Thornock. Councilmember Bill Price and Councilmember Mark Quinn and were absent.

Motion was made by Councilmember Thornock to excuse the absence of Councilmember Price and Councilmember Quinn; seconded by Councilmember Hicks and unanimously approved by Council present.

Motion was made by Councilmember Hicks to approve the agenda as amended to include the Color Run presentation; seconded by Councilmember Bowen and unanimously approved by Council present.

Brian Muir, City Administrator, made comments to the council. Mayor Thek made comments. Councilmember Thornock made comments.

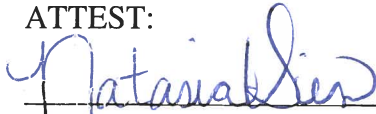
