- (e) authorize the Mayor to sign the 2023 Mosquito Grant Agreement.

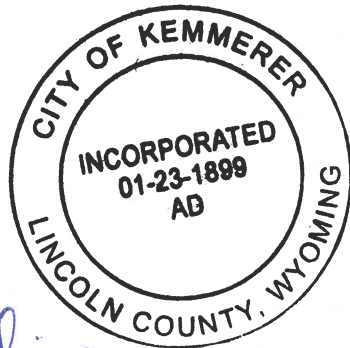
NEW BUSINESS:


COMMENTS:


