NEW BUSINESS:

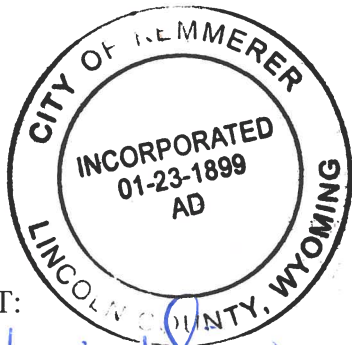
